FROM POINTS SOUTH

Take the Garden State Parkway North to exit 138. Make left turn going South on Boulevard (Route 509), after crossing over Garden State Parkway make right into Gallop Hill Golf Course

FROM POINTS NORTH

Take the Garden State Parkway South to exit 138, make right going North on Boulevard (Route 509), cross over Garden State Parkway and make first right for U-Turn. Make left going South onto Boulevard (Route 509), cross over Garden State Parkway and make first right into Gallop Hill Golf Course.

FROM POINTS WEST:

Follow Route 22 East to Michigan Avenue South. Follow Michigan Avenue South to Boulevard (Route 509), make left and follow Route 509 North over the Garden State Parkway and make first right and make a U-turn. Cross back over the Garden State Parkway and make your first right into Gallop Hill Golf Course.

FROM NEWARK AIRPORT AND POINTS EAST:

Take Route 1&9 North to Route 22 West. Follow Route 22 West to Garden State Parkway South. Take the Garden State Parkway South to exit 138, make right going North on Boulevard (Route 509), cross over Garden State Parkway and make first right for U-Turn. Make left going South onto Boulevard (Route 509), cross over Garden State Parkway and make first right into Gallop Hill Golf Course.

All those career advice books and websites tell us getting laid off can be a good thing. The unwelcome action can inspire you to find the work you really love, not just work to pay bills. Michael Leggiere is the shining example of the truth of that advice.

He was a newlywed in 1971 when he was laid off by Chiquita Banana and agreed to spend some time to assist his cousin, Nick Mastorelli, in administering the grants that funded North Hudson Community Action Corporation. He saw the needs of his neighbors desperate for jobs, housing, day care, and more opportunities for their kids. He cared deeply about them.

From devoting a few hours spare time, he rose to become Nick's assistant, and when Nick left to run for Congress in 1978, Michael agreed to take over the entire task. After Nick lost election, he declined to return to NHCAC because he felt Michael was doing a wonderful job there.

"His heart was in it," said Lois Leggiere. He saw every day as a new challenge. For instance, when HIP Insurance decided to leave the area, Michael saw an opportunity to create a "look alike" health center to help people without insurance. It was difficult to find the right building, the essential equipment, the staff and the funding. But he succeeded in 1997, and only a few years later he converted the "look alike" into the real thing, a Federally Qualified Health Center.

And the rest, as they say, is history.

We are proud to carry on Michael's legacy to the people of the North Hudson community.
