## **About NHCAC**

North Hudson Community Action Corporation (NHCAC), a major not-for-profit organization located in Union City, New Jersey, has a strong legacy of providing social services and health care to the communities in Northern Hudson County. The Organization began in 1965 as a small Community Action Program; it quickly expanded to include over 750 employees and over 22 sites and locations. North Hudson Community Action Corporation provides health care services at its ten Federally Qualified Health Centers (FQHC), and offers community support services through administration of 20 social services programs.

In 1977, North Hudson Community Action Corporation sought to fulfill the childcare needs of its low-income Hispanic population. Head Start was added as a social service program to the North Hudson Community Action Corporation in 1978, providing comprehensive child care services to pre-school age children. Early Head Start classes were added to the Corporation in 1999 to expand childcare services to eligible families who demonstrated the need for infant-toddler care. Today, North Hudson Community Action Corporation offers early education and supportive health and family services to 367 preschoolers; 104 infant and toddlers; and 30 expectant mothers.

North Hudson Community Action Corporation Head Start/Early Head Start (NHCAC HS/EHS) maintains its promise to fulfill the mission of implementing a holistic approach to engage families as the primary educators of their children, while ensuring that each child is school- ready by the end of the program year.

# Head Start/Early Head Start Programs

NHCAC HS/EHS prepares its students to enter kindergarten with the skills, understanding and knowledge to succeed. We provide a robust preschool program and provide full day, Monday through

Friday, year round services.

We provide a range of individualized services in the areas of education, medical, dental, mental health, nutrition, and social services to children and their families.

Parent engagement is valued and highly encouraged in all aspects of the program.

NHCAC HS/EHS families greatly benefit from the close integration of many other services and activities provided by the North Hudson Community Action Corporation to engage families and the community, and to build families' knowledge, skills, and health as well as life opportunities.






# **Independent Financial Audit**



# Head Start Parent Success Story: Yanira Mendoza - Cevallos



How did Head Start impact our lives? How did our mom being a part of Head Start impact our lives?

Gail:

Being at Head Start is one of my most prominent memories. The teachers, the students, and parent volunteers all contributed to our learning journey and helped properly prepare me to move onto kindergarten and so on, although we were a low income family. The best parts were knowing that I wasn't losing a part of my identity and culture, with bilingual teachers and programming that celebrated the countries we came from. It was important for young children of immigrant families to have a foundation such as that, and I am lucky I was able to be a part of that growing up. I am sure that this program helped me be as proud as I am of my Latin heritage.

The greatest pleasure throughout the years however, was seeing how involved my mother got. During my time there, my mom would volunteer at celebrations and other programming, and continued her time there when my younger sister attended. She eventually moved onto being a Teaching assistant and then onto their Administrative Offices. Seeing her further her education and career through Head Start was inspiring, knowing that my mom was helping countless families such as ours. This is actually what inspired me to get into more non-profit work!

The help that Head Start offers families is incredible, and every day I am thankful that they were able to help ours. Head Start has offered our family, especially my mother, countless resources and opportunities to not only live our lives, but further our futures. There's one thing I could say for certain, I would not be where I am now without Head Start.

#### Genesis:

My favorite part about growing up in the Head Start program was not only learning in such an encouraging environment, but also being a part of a community that truly felt like a family. The value

that comes with a Head Start education is one not often available to families that are still working their way up in the world. The teachers and staff treat the children as their own, and aim to nurture them where their development matters the most. Their enthusiasm always affected us as kids; as rowdy as we were, we would always be so patient and excited to hear our teacher's story or activity of the day. There are not many children who are always excited to attend school, but those of us who were raised within Head Start were definitely one of the lucky ones.

Although I can remember many of Head Start's staff fondly, my number one Head Start member will always be my mother, Yanira Mendoza-Cevallos. It's hard to express in words how proud I am to be her daughter. It is very easy to have a child, but it's really tough to be a mom. Despite this, my mom has consistently extended her love and care beyond our home and out towards everyone in the Head Start, be it the staff or the children. Her time at Head Start helped her to graduate from college and continue pursuing her career. She's now a manager within the Administrative Office, helping families like ours who only want the best for their children. I can't imagine a better place for her and her warm, loving personality to thrive in. Even though she's no longer in the classroom, it's evident that the curiosity and passion for learning that Head Start encourages never left. I can only hope to grow into the wonderful woman she has become.

It's thanks to my family and their experiences within Head Start that I love learning and interacting with others the way that I do. Seeing my mom grow into a professional position at Head Start and volunteer in all of its events for the community inspires me to always help and extend kindness to those around me.







# Overall score in the following areas:

In reviewing the 2020-2021 School Readiness Program outcomes, the target overall goal for TSGOLD assessment was 90% in all Domains. In comparing the Teaching Strategies Gold pre-k 3 and pre-k 4 student outcomes data, the table below demonstrates that Pre-k 3 students were at an average of 23% below the expected Target Goal in all TSGOLD Domains. Pre-k 4 students were at an average of 11% below the expected Target Goal in all TSGOLD Domains.

# 2020-2021 Early Head Start School Readiness Data: Period 1 and 3 Comparison High Scope Assessment: COR Advantage

## Data comparisons: Period 1: 2020 Scores compared to 2021 Period 3 Scores

When developing the Early Head Start Goals for 2021 -2022 school term, scores from the High Scope Assessment tool: COR Advantage were analyzed. COR Advantage scores were tabulated from period 1 of 2020 and compared to the COR Advantage scores from period 3 of 2021. As we compared the Period 1 average scores from 2020 to Period 3 average scores from 2021 for the NHCAC EHS Program (5800 & 4ths St. Sites), we highlighted the highest scoring COR Advantage Categories and lowest scoring Items from these Categories.
