US Department of Health and Human Services (DHS), Office of Head Start (OHS) request proposals for the 2023 Cost of Living Allowance grant of a 5.60% increase or \$363,299 to permanently increase salaries, and fringe benefits. US Department of Health and Human Services (DHS), Office of Head Start (OHS) also request proposals for the 2023 Quality Improvement grant to allow for meaningful quality improvement investments using a predetermined allocation of \$180,611 based on program enrollment.
